

## OTHER REQUIREMENTS

If your spouse is not over 65 years of age, your name must appear on the deed to the property.

The home must be your primary residence.

## CONTINUING HOMESTEAD EXEMPTION

Upon acceptance, every January you will receive a **Continuing Homestead Exemption Form**.

*Please note: You do not need to return the application each year if there is no change in income.*

## FILING PERIOD

Applications can be submitted between the first of January until the first Monday in June of every year.

## FORM AVAILABILITY

The application form is available from Frank J. Gliha, Geauga County auditor, online at [www.auditor.co.geauga.oh.us](http://www.auditor.co.geauga.oh.us) or by email at [taxrelief@co.geauga.oh.us](mailto:taxrelief@co.geauga.oh.us) or by calling (440) 279-1617. You can also request a form by mail or in person at the Auditor's Office.

## NOTIFICATION OF ACCEPTANCE

The Auditor's Office, based on Ohio Law and review of the information you provide, will determine if you qualify for the Homestead Exemption. You will receive notification of status in October of the year you apply.

## EFFECT ON OTHER REAL ESTATE TAX REDUCTIONS

You will continue to receive the 2.5% owner occupied rollback that you presently receive. The Homestead Exemption is an **additional reduction** in your real estate taxes.

## MANUFACTURED HOMES (MOBILE HOMES)

If you meet the qualifications listed in this brochure and own a Manufactured Home (mobile home) in Geauga County you may apply for a **reduction** in Manufactured Home taxes.

## PENALTY FOR PROVIDING FALSE INFORMATION

If false information is provided on an application, the applicant will be ineligible to receive the exemption for the next three years and may be subject to a fine.

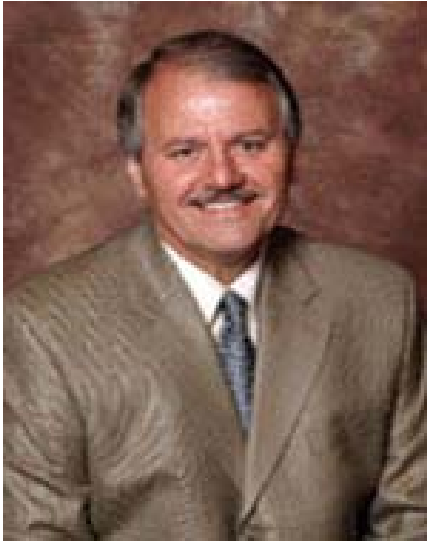

## HOMESTEAD EXEMPTION

### ELIGIBILITY

You are eligible for the Homestead Exemption

if

You are 65 years of age or older (you may file your application the year in which you will become 65) and living in a home you own (your name appears on the deed) in Geauga County.

or

You are less than 65 years of age, are living in a home you own in Geauga County and have been certified 100% totally and permanently disabled by a licensed physician.

or

You are the surviving spouse of a qualified homeowner, and who was at least 59 years old on the date of their spouse's death.

### ***“permanently and totally” disabled***

Section 4503.064 of the Ohio Revised Code defines “*permanently and totally disabled*” as a person who has . . .

*“. . . some impairment in body or mind that makes him unfit to work at any substantially remunerative employment which he is reasonably able to perform and which will, with reasonable probability, continue for an indefinite period of at least 12 months without any present indication of recovery there from or has been certified as permanently and totally disabled by a state or federal agency having the function of so classifying persons . . .”*

## Real Tax Relief

Here's how the Homestead Exemption works. Eligible homeowners are able to shield \$25,000 worth of the market value of their home from local property taxes. For example, the owner of a \$100,000 home who is eligible for the Homestead Exemption would be billed as if the home were worth \$75,000.
